<u>SELECTED PROGRAM INVOLVEMENT IN PREVIOUS RESEARCH POSITIONS</u> (2010 to 2017)

Conditions of Children in or at Risk of Foster Care in Illinois: The Annual Monitoring Report of the B.H. Consent Decree (multiple years, annual reports from 2012 to 2016). This is a major CFRC project that uses state administrative data to monitor child welfare system performance and outcomes. I was a team member for the writing of the report.

Illinois Differential Response program evaluation. The multi-year evaluation adopted randomized trial design and surveyed over 8,000 families in Illinois to test the effect of Differential Response strategy in responding to child maltreatment reports. I was a major evaluation team member.

Illinois Child Death Review Team Annual Report (multiple years, annual reports from 2013 to 2016). The annual project uses administrative data to describe child deaths (about 1,500-1,600 annually, including about 10% of the deaths due to child abuse and neglect) by 5 manners and 13 categories in Illinois and summarizes policy and practice recommendations primarily to the Department of Children and Family Services, with the goal to reduce preventable child deaths. I

was responsible for communicating with program staff, conducting data analyses, and writing the reports.

Justice and Mental Health Collaboration Program. The program is funded by a grant from the Department of Justice to the Champaign County to develop collaboration including data sharing across multiple justice and social service agencies in Champaign County, IL, for the purpose of reducing recidivism and facilitating released individuals' community reentry. As a Data Consultant (PI), I developed database (E-Screening tool) for the County jail to facilitate inmates' mental health/substance abuse screening and data collection/analysis, and conducted outcome assessment to evaluate the effect of the program.

"Now Is the Time" -AWARE-Community Project (Youth Mental Health First Aid training). The project is funded by the Substance Abuse and Mental Health Services Administration (SAMSHA) to train over 2,000 Youth Mental Health First Aides to improve community's capacity responding to youth mental health problems. As the program evaluator (PI), I designed, planned, and implemented program evaluation; developed multiple data collection instruments to collect data from program participants, staff, and service agencies; and analyzed data and wrote evaluation reports aimed at program's continuous quality improvement.

Maternal Infant and Early Childhood Home Visiting program. The statewide program was funded by the state through a fund form the Health Resources and Services Administration (HRSA), USDHHS. The program involves many services agencies applying multiple service models to strengthen vulnerable families with diverse needs. Task was primarily in data analysis.

Illinois Youth Suicide Prevention Program. The project is funded by the state through a funding from SAMSHA. The evaluation assesses the effect of youth suicide prevention training programs that uses various modules (e.g., modules for middle/high school students; college students; LGBT individuals; and veterans). Tasks included data cleaning, analysis, and report producing.

Illinois Youth Survey. The project is a statewide biannual survey which primarily examines middle school/high school students' substance abuse and other adverse behavioral health problems. Tasks included data validation and analysis responding to district report requests.

Investing in Innovation (i3) School Projects. Worked on several i3 projects which assessed promising initiatives aimed at improving student academic achievement and strengthening school leadership capacity. Tasks included data analysis and report producing.

Engaging Youth for Positive Change (EYPC). The EYPC was a multisite statewide program aimed at promoting youth civic engagement through engaging them in local policy advocacy process. Tasks primarily included data analysis and research development.
